ORDER

As per B.O. read as 1st above, sanction was accorded for the formation of a Civil Sub Division for the execution of construction works under Electrical Circle, Shoranur.

The Chief Engineer (Distribution North), Kozhikode as per letter read as 2nd above has reported that the Civil Sub Division is functioning under the administrative control of the Deputy Chief Engineer, Electrical Circle, Shoranur with head quarters at Shoranur for the execution of the construction works including Mini Vidyuthi Bhavanam, Mannarkkad, Sub Regional Store, Shoranur, Mini Vidyuthi Bhavanam, Pattambi for accommodating the offices of Electrical Division, Electrical Sub Division and Electrical Section, Pattambi and the proposed building for Electrical Sub Division, Cherpulassery. It is reported that the construction of Mini Vidyuthi Bhavanam, Mannarkkad has already started and the work of Sub Regional Store has been awarded and the work is expected to start in two weeks. The building for Electrical Division, Pattambi is in the tendering stage. The Deputy Chief Engineer, Electrical Circle, Shoranur requested for a vehicle on contract basis exclusively for the use of Civil Sub Division office for the execution and supervision of the above works in a speedy manner and for a time bound completion.

In the above circumstances, the Chief Engineer (Distribution North), Kozhikode has requested sanction to hire a vehicle (below 1,500cc) with a monthly running limit of 1,500 km for the use of Civil Sub Division, Shoranur till the completion of the above works or the date of expiry of the functioning of the Civil Sub Division, whichever is earlier.

The matter was placed before the Full Time Directors as per note read as 3rd above.

Having considered the matter in detail, the Full Time Directors in the meeting held on 09/10/2020 resolved to accord sanction for hiring a vehicle (below 1,500cc) with a monthly running limit of 1,500 km for the use of Civil Sub Division, Shoranur for a period of one year.
